### **3. Recruitment of Volunteers for Vancouver Coastal Health's Community Engagement Advisory Network**

Belinda Boyd, Director of Community Engagement for Vancouver Coastal Health Authority (VCH) provided an overview of the Authority's Community Engagement Advisory Network. The Network comprises volunteers from the community, including older adults, who would like to have a voice in healthcare policy development (e.g., patient outcomes; advance care planning). The Network does not have a set meeting schedule, but opportunities for involvement in specific issues/projects are communicated to members through a weekly newsletter. There is no specific time commitment; volunteers can be as involved as they wish. Eddy Elmer indicated that he would advertise the Network on the Committee's social media sites. Members discussed the possibility of forming a healthcare subcommittee.

### **4. Changes to East Side 49th Avenue Bus Route**

Heather McCain, executive director of Citizens for Accessible Neighbourhoods (CAN), indicated that TransLink plans to cut part of this route to increase reduce time and save money. According to Ms. McCain, the cut would negatively impact older adults, persons with disabilities, and families with children, particularly since the Champlain Heights Community Centre and the only grocery store in this area is located along the portion of this route to be cut.

Ms. McCain indicated that TransLink's process for collecting feedback about this change was inadequate, given that it relied primarily on an online survey. She insisted that more feedback be sought from older adults and families about the impact of this change.

She also suggested alternate ways to reduce transit times along this route, but TransLink does not appear to have been receptive to the neighbourhood suggestions. She asked if the Committee would draft a motion calling on Council to ask TransLink not to make the proposed cut. The Transportation and Mobility Subcommittee will draft this motion, underscoring that TransLink may have approached this change from an able-bodied perspective.

Gudrun Langolf suggested that when TransLink plans future route changes, it should provide paper questionnaires on the busses that are directly affected.

**ACTION:** TAM Subcommittee to draft a letter to Council for consideration at the January meeting. The letter is to include the suggestion that TransLink make paper surveys available to riders of the route when a route change is proposed.

### **5. Request for Letter of Support for Community Engagement Research Project**

Dr. Atiya Mahmood, Associate Professor of Gerontology at Simon Fraser University, and her graduate student, Heather Cowie, provided an overview of a research project they are planning: "Neighbourhood Social and Built Environment and Health Literacy: A Community Engagement Strategy to Enhance Mobility and Well-being in Older Adults."

This participatory action project, which will be conducted in co-operation with the South Granville and Kitsilano Neighbourhood Houses, has three main goals:

- a. To give older adults, in the areas served by the neighbourhood houses, an opportunity to identify environmental barriers in their neighbourhoods that impede mobility and social engagement (e.g., by doing neighbourhood audits using cameras or other recording equipment)
- b. To identify and measure the biographical and environmental aspects of health literacy in later life to understand the role that neighbourhoods play in the health and wellbeing of older adults
- c. To examine characteristics of social engagement opportunities that draw older adults into the community, as well as how they may overcome common age-related barriers to social participation

Dr. Mahmood and Ms. Cowie asked if the Committee would write a letter of support for the project that could be used to help secure funding from CIHR. Members agreed to write a letter, noting that data gleaned from this project could be very useful for the Committee's own work on housing and mobility and could provide excellent opportunities for intergenerational contact (e.g., young people from the neighbourhood houses could help older adults use technology, and older adults could show younger people the environmental barriers they face).

**ACTION:** Eddy Elmer and Thomas Crean to work with Dr. Mahmood to draft the letter, underscoring the ways in which the project is relevant to the Committee's mandate.

Members also asked Dr. Mahmood if she would be willing to work with the Housing Subcommittee to create a checklist for staff regarding the essential elements of seniors' housing. She and her student agreed to help.

**ACTION:** Eddy Elmer will follow up and help coordinate Dr. Mahmood's attendance at a future Housing Subcommittee meeting.

### **Minutes of the Transportation and Mobility Subcommittee Meeting (November 20)**

We had our meeting on November 20, 2015 with Gudrun Langolf, Scott Ricker, Bob Worcester and myself, in attendance. Angie Natingor did not attend the meeting as she had to recuse herself from the first part of the SAC meeting because of potential conflict of interest.

#### **Issues Discussed**

Gudrun sent out a poster about World Toilet Day which generated a vigorous discussion about the necessity of public toilets in public spaces. Gudrun will be drafting a motion re public toilets for discussion and possible submission to SAC.

Dellie brought forward a complaint from a senior in Kits Neighbourhood House regarding the lack of signage directing people to Granville Island from the south-end of the Granville Bridge going into the Cloverleaf. This is the second time this issue was raised by someone from the Neighbourhood House. This time, it involved a person in a wheelchair who was trying to find his way from the bridge to Granville Island. The person was disoriented and did not know which direction to go. Fortunately, the senior was able to give him directions. We think that more prominent directional signs directing people to Granville Island, which is a popular tourist attraction, are called for.
